- 3) Spay/neuter certificate, if applicable.
- 4) Current License Fees are per dog:
\$10.00 if the dog is spayed or neutered
\$20.00 if the dog is NOT spayed or neutered
\$25.00 Enumeration Fee (If dog is not registered by 6/30/2017)

If you do not reside in the Town of North East

Did you know?

Article 7 of the **New York State** Agriculture and Market Law **requires** all dogs older than 4 months to be licensed within the town they reside. Licensing ensures that all dogs have been properly vaccinated against rabies for the protection of both you and your neighbors. If your dog is **NOT** yet vaccinated there may be a low cost clinic in your area. Please contact 518-789-3300 Ext.603 for more information. Licensing ensures that your dog has the best chance to be returned to you the owner. **Any dog living with you for more than 30 days must be licensed.**

If you have any questions, please call 518-789-3300 Ext.603.

The dog control officer will be doing random house visits to ensure census accuracy beginning 6/30/2017. If at this time you have not returned your form and are found to be harboring an unlicensed dog(s) you could be subject to imprisonment and/or court fines, along with a one-time enumeration fee of \$25.00 per dog that will be added to the dog license base fees.
