**Call to Order:**

Supervisor Kaye called the meeting to order at 7:00 PM.

**Acceptance of Agenda**

Supervisor Kaye stated that there were some amendments to the agenda:

- 1) Completed Millerton Pedestrian Plan
- 2) Revisions to Employee Handbook
- 3) Town has received the quick claim deed to the property that was purchased for the Town/Highway Garage
- 4) JCAP Grant

On a motion made by Councilman Merwin, seconded by Councilman Kennan it was:

**Public Comment on Agenda Items Only**

MaryLynn Kalogeras asked what the procedure is with regard to appointing individuals to the Boards and if the Town Board is familiar with the people.

Supervisor Kaye explained that with regard to the Comprehensive Plan appointment it was a replacement of a Village member with a person who is also currently a member of the Village of Millerton Planning Board.

Supervisor Kaye explained that Planning Boards can be tasked with the process of doing the entire Comprehensive Plan. It was chosen not to go that route because it only shows one aspect of the entire spectrum of both the Village and Town. However, representation from the Planning Boards must be on the Comprehensive Plan Committee.

Supervisor Kaye explained that with regard to the Planning Board position for the Town it was published in the paper, posted at the Post Office and on the Town website. Three different people put in applications for this position and the entire Town Board interviewed the individuals and voted on the appointment.

Supervisor Kaye explained that in certain instances a specific type of person may be being sought to represent a certain part of the community.

Bill Kish asked if there was a meeting where the Planning Board member was voted upon.

Supervisor Kaye explained that there was a special meeting, which was advertised, where the Board went into executive session to interview the applicants for the Planning Board. The entire Board was present at said meeting.

Ms. Kolageras asked if the Town Attorney could come at the end of the meetings.

Supervisor Kaye explained that in certain instances there are public hearings and the need for the attorney to be there is important and to keep him until the end wouldn't be cost effective.

**Department and Committee Reports**

**POLICE** – Dave Rudin informed the Board that there were 40 incidents in the month of January; 14 in the Town, 26 in the Village that included 2 arrests in the Village and one in the Town.

A member of the audience asked Officer Rudin how much, if any, has narcotics increased in the community.

Officer Rudin stated that rescue squad calls for overdoses have gone down in this area. As far as drug activity, many of the community's drug dealers have been arrested or moved out of the community.

**HIGHWAY** – Superintendent Stevens informed the Board that the results of the surplus equipment were as follows:

- 1) 2003 John Deere loader the bid was \$31,500 and he recommends the Board accept this offer.
- 2) Hydraulic wheel loader forks the bid was \$1,925.00 and he recommends the Board accept this offer.
- 3) 2000 York Broom the bid was \$240 which he recommends making a \$500 counter offer.
- 4) The used tires bid was \$330 and he would recommend the Board accept this offer.

Superintendent Stevens presented the Board with the bid for on road diesel and 89 Octane gasoline. Only one bid was received from Botini fuel which is the Town's current supplier. The price went up two cents per gallon from last year.

Town Clerk Cope explained that at the bid opening on January 18, 2018 they did not have bids in hand. Superintendent Stevens then called the two companies he knew he would get bids from and was informed by Botini that they had over-nighted a bid to the Town which was to arrive on January 17, 2018. However, due to the fact that the Town Hall was closed on January 17, 2018 due to a snow closure.

Town Clerk Cope spoke with Town Attorney Replansky and explained the situation. Attorney Replansky stated that if the bid was acceptable and due to the fact that it was over-nighted and due to arrive on the bid date it can be an acceptable bid.

Superintendent Stevens addressed a complaint that was received by the Town with regard to a Town truck being seen in Stanfordville on February 7, 2018. He stated that the facts are that he took a driver to Stanfordville yesterday to pick up a plow truck and no stops were made by either truck going to or coming back.

Councilman Fedele thanked Superintendent Stevens for providing him with the schedule showing the life span of equipment.

**PLANNING, ZONING & BUILDING** - Written reports were made available to the Board.

**ASSESSOR** – A written report was provided and read by Town Clerk Cope.

**TOWN CLERK** – A written report was made available to the Board.

**COMMITTEE ACTIVITY** – No reports

Councilman Midwood discussed the possibility of having the Town provide \$2,400 in taxpayer dollars towards equipment to be used for recording meetings. This would be in conjunction with \$2,600 the

Town received in a grant. He would prefer to have the system set up right and not have to upgrade in order to provide a quality product.

Councilman Midwood stated that he has researched equipment and his vision is to have a camera mounted in such a way so as to show the whole Board in the video. The goal would be to have a system that can be controlled by a remote and suspended in a way to show the whole Board and to acquire such a system would be difficult to be purchased for under \$5,000.

Supervisor Kaye asked Councilman Midwood to gather more exact figures and present them to the Board.

Councilman Fedele stated that he was concerned with the proposed angle of the camera. He felt that with the way the Board is seated it wouldn't give a clear view of who is speaking.

Councilman Midwood explained that he is trying to be creative with the space and its limitations.

Councilman Midwood stated that the cost would include the camera, equipment mounted, installation and remote.

Councilman Midwood stated that the previous system was extremely time consuming.

Councilman Kennan asked if other Towns have the ability to show the audience.

Councilman Midwood explained that they do however these Towns have a very large annual budget.

**RESOLUTION ADOPTING LOCAL LAW NO. 1 OF 2018**

**WHEREAS**, Section 458-b of the New York Real Property Tax Law (“N.Y. RPTL”) provides an exemption from taxation to qualified residential real property owned by Cold War Veterans and/or qualified owners for a period of ten years provided municipalities adopt a local law authorizing the same; and

**WHEREAS**, Chapter 155, Article IV of the Town Code established an exemption from real property taxes for Cold War Veterans in accordance with Section 458-b of the N.Y. RPTL with a ten year limitation; and

**WHEREAS**, recent amendments to Section 458-b of the N.Y. RPTL provide that municipalities may adopt a local law providing that the exemption authorized by this section shall apply to qualifying owners of qualifying real property for as long as they remain qualifying owners, without regard to a ten year limitation; and

**WHEREAS**, the Town Board desires to extend the aforementioned exemption in accordance with the statutory amendments to Section 458-b of the N.Y. RPTL, which became effective on September 12, 2017; and

**WHEREAS**, the Attorney to the Town has drafted a proposed Local Law amending Article IV, Section 155-12(C) of the Town Code to extend the Cold War Veterans exemption, as provided in the recent amendment to Section 458-b of the New York RPTL; and

**WHEREAS**, the Town Board duly noticed, advertised and conducted a public hearing on the adoption of said Local Law on February 8, 2018; and

**WHEREAS**, there was no opposition to the passage of said Local Law and the Town Board members have determined that the passage of the Local Law is in the best interest of the Town of North East and its veterans.

### **Acceptance of the Pledge to Become a Climate Smart Community**

Councilman Kennan explained that the climate smart program is a program of NYS to involve municipalities in taking steps to reduce greenhouse gas emissions and to help municipalities adapt to a changing climate. This program has been around for some time. It involves taking a pledge to take a series of steps involving assessing the natural resources of the Town and finding ways as the Town moves forward to be sensitive to climate issues in its planning.

Councilman Kennan feels that this is very relevant to the Comprehensive Plan update. The first step in the process is to actually pledge to pursue the process. There are no mandates other than finding out what the Town has and working to factor in climate issues in planning and building etc. as the Town goes forward. Having taken the pledge it enables the Town to receive a grant that would go towards doing an assessment of its resources.

Councilman Kennan would recommend that the Town enter a pledge.

**RESOLUTION ADOPTING TOWN OF NORTH EAST CLIMATE SMART COMMUNITIES  
PLEDGE**

**WHEREAS**, The Town of North East believes that climate change poses a real and increasing threat to our local and global environments and is primarily due to the burning of fossil fuels; and

**WHEREAS**, the effects of climate change will endanger our infrastructure, economy and livelihoods, harm our farms, orchards and ecological communities, including native fish and wildlife populations; spread invasive species and exotic diseases; reduce drinking water supplies and recreational opportunities; and pose health threats to our citizens; and

**WHEREAS**, The Town believes that our response to climate change provides us with an unprecedented opportunity to save money, and to build livable, energy-independent and secure communities, vibrant innovation economies, healthy and safe schools, and resilient infrastructures; and

**WHEREAS**, The Town believes the scale of greenhouse gas (GHG) emissions reductions required for climate stabilization will require sustained and substantial efforts; and

**WHEREAS**, The Town believes that even if emissions were dramatically reduced today, communities would still be required to adapt to the effects of climate change for decades to come.

**NOW, THEREFORE**, be it

**RESOLVED**, the Town of North East, in order to reduce greenhouse gas emissions and adapt to a changing climate, adopts the New York State Climate Smart Communities Pledge, which comprises the following ten elements:

1. Pledge to be a Climate Smart Community.
2. Set goals, inventory emissions, plan for climate action.
3. Decrease community energy use.
4. Increase community use of renewable energy.
5. Realize benefits of recycling and other climate-smart solid waste management practices.
6. Reduce greenhouse gas emissions through use of climate-smart land-use tools.
7. Enhance community resilience and prepare for the effects of climate change.
8. Support development of a green innovation economy.
9. Inform and inspire the public.
10. Commit to an evolving process of climate action.

**Resolution Authorizing the Town of North East Supervisor to Enter Into an Agreement Amending the Inter-municipal Agreement for Equipment Sharing of the Bucket Truck Dated March 3, 2016**

Supervisor Kaye explained that this bucket truck was originally a shared service between Milan, Rhinebeck and Clinton. They had received from the County \$194,000 for the purchase of the bucket truck and for legal issues that were involved. At the time, the Town believed it had access to a bucket truck however this may not be the case.

Supervisor Kaye stated that he then approached the other Towns to see if we could become a partner on the bucket truck. This would entail the legal drafting of documents, receiving the approval to join from the aforementioned Towns and the costs for insurance and repairs as needed.

Mr. Replansky explained he has passed this by County Planning and they have not offered any comments or critiques. So this IMA needs to be signed and sent to the other municipalities.

Supervisor Kaye stated that the agent has proposed the possibility of an optional coverage increasing the premium for dishonest employee coverage from the current limit of \$100,000 to \$500,000. This would be at an additional premium of \$478.

### **Millerton Pedestrian Plan**

Councilman Midwood informed the Board that the Committee met for about three hours a month for the past year. They worked with the Dutchess County Transportation Council. The final product is a 92 page document.

Councilman Midwood stated that the idea is to have this added as an addendum to the Comprehensive Plan. This document can be adopted by the Village and Town so grants can be applied for.

Councilman Fedele stated that in order to implement this it will take a lot of money which the Town and Village do not have.

Councilman Midwood explained that this document can be used to apply for grants. He suggested the Town and Village hire a grant writer. He stated that this is a Town and Village issue because the Village is the commercial center of the Town.

The Pedestrian Plan will be posted on the Town's website.

### **Revisions to Employee Handbook**

Supervisor Kaye explained that in discussion with Highway Superintendent Mr. Stevens some revisions to the current handbook as it pertains to highway department summer work hours needed to be made. The revision to be made is as follows:

The Highway department will operate under a four day summer work schedule for the period beginning the first Monday in May until the last Friday in August. This schedule will consist of four 10 hour days from 6AM until 4:30 PM Monday thru Thursday with a half hour lunch break.

Supervisor Kaye explained that the next item to be changed was the usage of vacation leave credits. These credits may no longer be used in increments of less than one hour. In the past it has read that time off needed to be taken off in increments of four hours. This does not work necessarily if someone just needs a couple of hours for an appointment or for part time employees. This now allows time to be taken off in one hour increments.

Supervisor Kaye explained that the last issue to be addressed is the paid leave for cancer screening. This is in relation to a new NYS law. In the past it only stated it was for breast cancer and prostate cancer screening.. It is now inclusive of screening for all cancer screenings.

### **Quick Claim Deed to the New Highway Garage Property**

### **JCAP Grant**

Supervisor Kaye explained that the Town Court has received a grant for half the purchase and installation for a heat pump for the courtroom. The grant is for \$2,404 and the Town will need to come up with the rest of the funds.



**Announcement of New CDBG Grant to make Town Hall Entrance Way and Door Ways ADA Compliant**

Supervisor Kaye explained that the Town and Village applied for a grant jointly for the amount of \$189,700. The CDBG grant amount available for all of municipalities in Dutchess County was \$875,000. There were 13 different applications for grants with a total of 7 being chosen. Amongst those seven the Town and Village's was chosen and will receive a total \$161,000.

Supervisor Kaye stated that the Town's share will be about \$55,000 the remainder is for the Village because what needs to be done in the Village is more extensive. The Town's portion will cover approximately 85%.

Supervisor Kaye explained that the scope of the work at the Town Hall will include the widening of the downstairs bathroom door, new front door with a ramp, widening of interior doorways.

Mr. Kish asked if there was anything discussed in the Executive Session that would put the Town in jeopardy of not winning the case.

Supervisor Kaye explained that it might have put the Town in jeopardy of not winning future cases.
