

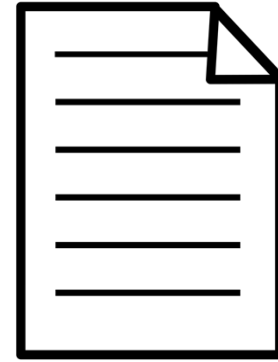

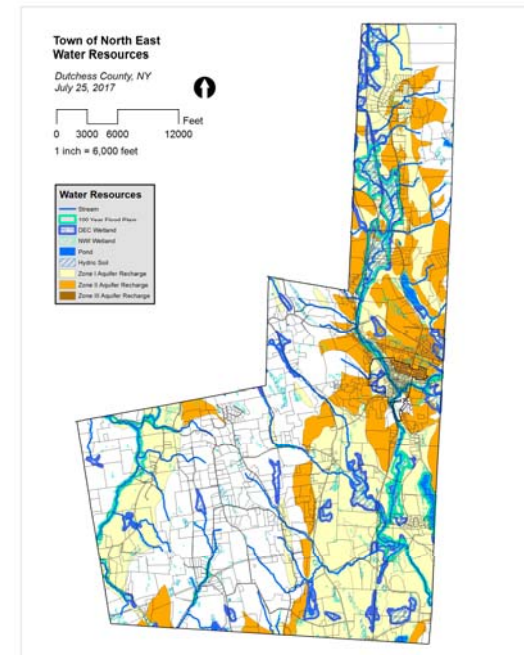

Planning Process

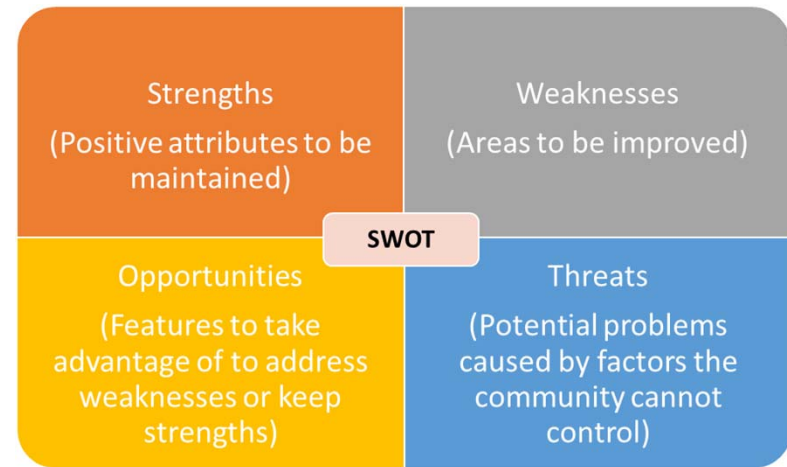
Data and Maps

- Inventory/description of economic conditions
- Inventory/description of infrastructure



Planning Process –

Develop Vision and Goals



- Analysis of all public input and data, including maps
- Organization of data into SWOT
- Development of vision statement
- Development of goals

About the Strategies to Meet Vision and Goals

- Recommends actions to be implemented over the next 10 to 15 years
- Strategies range from regulatory improvements to capital improvement projects
- Over 100 different strategies recommended
- Plan identifies several priority short term and long term strategies as top priority to implement

Highlights of Priority Short Term Strategies

- Create unified community calendar
- Reestablish Ag Committee and form other committees to help with implementation
- Host annual Town/Village Hall meeting
- Develop town-wide email list to enhance communication
- Support community-based nonprofit organizations

Highlights of Priority Long Term Strategies

- Install public sewers
- Sidewalk improvements
- Ongoing improvements at Eddie Collins Memorial Park
- Plan for 5G wireless
- Update zoning and subdivision laws in both Town and Village
- Develop comprehensive parking program in Village
- Implement Climate Smart projects

Highlights of Other Suggested Strategies

- Better signage to venues and parking areas
- Create bike lanes and more biking opportunities, ride and bike sharing
- Create marketing and promotion program
- Implement economic development program ideas

Highlights of Other Suggested Strategies

- Develop 5-year Capital Improvement Plan
- Develop Complete Streets Program
- Update historic inventory
- Inventory and map important viewsheds
- Feasibility study on need for a shared community kitchen

Suggested Regulatory Oriented Strategies

- Process
 - Improve definitions
 - Update purpose statements
 - Update special use and site plan review sections
 - Add in modified site plan review for ag uses
- Development Standards:
 - Incorporate Greenway Guides
 - Integrate Habitat Study recommendations
 - Require sidewalks in Village
 - Update parking lot siting and landscaping
 - Use inclusionary zoning to promote more affordable housing
 - Use traditional neighborhood design in Village

Suggested Regulatory Oriented Strategies

- Development Standards:
 - Update Boulevard District
 - Add and illustrate design and siting standards for commercial buildings
 - Use conservation subdivisions
 - Farm-friendly standards
 - Expand use of overlay district to protect environmental features
- Update Allowed Uses and Dimensions
 - Update for Boulevard District
 - Adjust lot sizes, density and dimensions to match existing
 - Allow for farm worker housing
